

CONSPIRACY AGAINST THE HUMAN RACE - FURTHER EVIDENCE

WHAT IS BEHIND ALL THIS CONSPIRACY BETWEEN PINOCHET AND VORSTER ?

In December 1974, the Chancery of the Chilean Fascist Junta handed to Pinochet a "Confidential" portfolio entitled "New External Strategy".

The basic contents of the document consisted of a secret plan to "consolidate and win friends". This was because of the resolution of the General Assembly of the United Nations which was already overwhelmingly condemning the violation of human rights by the Pinochet regime.

It is unnecessary to stress that the South African racist regime, since the fascist Military coup in Chile, has become a natural ally of Pinochet's Junta and as such, has been described by the latter as a "friendly country". Nonetheless, for some time, the Pinochet Junta was careful not to publicly show these links with South Africa, daily growing closer, because of the rejection this met with in the Chilean populace and "because of its degree of international isolation", according to the very expression of the brains behind the "Confidential" memorandum.

As 1975 drew to a close, the resounding failure of the so-called "new external strategy" was clear, hardly a year after its design by the Chilean fascists. A second and more forceful condemnation came from the General Assembly of the United Nations, this time supported by a greater number of countries than the previous year. It was demonstrated that Pinochet's group of fascists had not changed one iota, on the contrary, they had in fact increased the violation of all human rights and public freedoms.

In December 1976 and December 1977, for the third and fourth consecutive times, the international community rejected the anti-human repressive policy of Pinochet, approving new and this time more forceful condemnations during the XXXI and XXXII sessions of the General Assembly of the United Nations.

With regard to the Vorster regime, if it ever at any time even thought of trying to improve its image, these plans were defeated by the regime's insistence on maintaining "Separate Racial Development", Apartheid, energetically condemned

by the peoples of the world through the United Nations, and by the armed aggression of October 1975 against the nascent Popular Republic of Angola, which merited the most categorical rejection of all progressive human beings.

The permanent aggressive and interventionist attitude towards the internal affairs of other African countries displayed by the South African regime has contributed to its situation of isolation not only being maintained, but aggravated even further.

DIPLOMATIC TIES

From 1974 to date, the changes which have occurred in the relationship between Vorster and Pinochet have been substantial - especially from the public point of view.

If at that time the fascist regime of Chile was careful not to publicize its secret links with the South African racist, now these have come to the surface due to the dynamics of the events which have occurred during such time and also as a consequence of the permanent rejection of the methods which have alienated new sectors from them and which has obliged Pinochet and Vorster to support each other, however it might be and even under the public gaze.

Pinochet received the South African Ambassador to Argentina, Robert A. du Plooy, in Santiago as a "guest of honour" at the activities of the Patriotic Festivals of September 1974.

The racist ambassador congratulated Pinochet, telling him, among many other things, that he was "very impressed by how he found the country" and giving out frantic eulogies to the repressive armed corps who filed past in the military parade, when he was on the rostrum to which all honour was being rendered.

In May 1975, not even a year after the previous visit, the new Ambassador of Vorster to Argentina, Heinrick Geldonhuy, landed at Pudahuel airport in Santiago.

In order not to arouse the greater anger of the Chilean people, a few days later, in secret and with no publicity, an official diplomatic mission from Vorster to Pinochet was opened. This is why the operation in question was allowed to pass unnoticed by the Chileans.

For his part, Pinochet had until that date maintained only three second-degree consular representatives with offices in Durban, Cape Town and Johannesburg.

At the end of 1975, Vorster offered Pinochet a loan of 450 million dollars in exchange for mercenary troops and a fascist embassy in Pretoria. Furthermore, Prime Minister John Balthazar Vorster showed keen interest in being received with all possible honours in Santiago.

The credit would basically be used for the supply of repressive armaments for the Pinochet fascist group and to carry forward a nuclear agreement between the two regimes.

After the secret talks, the Pinochet dictatorship installed a Consulate General in Pretoria, days before the beginning of 1976, designating Corvette Captain Carlos Ashton as its chief diplomatic representative.

Ashton had been one of the main brains behind the Psychological War against Chile before and after the fascist Military Coup. From the radio station he managed, Radio Sociedad Nacional de Agricultura, panic was created in Chile; misinformation was permanently and scientifically broadcast; the legitimate President of Chile, Dr. Salvador Allende, was insulted in the crudest manner; the fascist coup was incited and over its transmitters the first proclamations of the Pinochet Junta were made known, together with the lists of Chilean personalities with a price on their heads.

At the time of his nomination in Pretoria, Ashton was employed as none other than Managing Director of External Broadcasting for the Chancery of Pinochet.

For his part, Vorster arranged for his Press Attache, Chris C. Badenhorst, to visit the propagandistic media of Chilean fascism. During his sojourn in the twilight of the "El Mercurio"/"La Segunda" chain, the special envoy of Vorster asserted that the isolation of his country was not due to the international repudiation provoked by the policy of apartheid and aggressions against the other African peoples, but a supposed world campaign against it.

Chris C. Badenhorst, in the name of the Vorster regime, drew a parallel between the situations of Chile and South Africa.

VORSTER SENDS PINOCHET PEOPLE FROM THE TRANSKEI

Coinciding with the visit of Chris C. Badenhorst, on 11th August 1976, a delegation from the Transkei Bantustan arrived in Santiago, headed by the supposed Minister of Health, Jeremiah Dibupuca Moshesh; the so-called "Minister of Roads and Public Works", George Sibidla Ndabankulu; the Private Secretary of the former, Malihambe Patrick Antonintshi; the Private Secretary of the latter, Fuzilo Gladwin Mgcai, and the pseudo-government official Digby Sqelo Koyano.

This visit had no other objective than to canvass the support of Pinochet's fascist group which has siezed the government in Chile for the XXXI General Assembly of the United Nations when South Africa was to announce that it had decided to grant "independence", obviously false.

The presence of these "governors" of Vorster in the so-called Transkei was widely publicized by the fascist-dominated press in Chile.

In the second week of August 1977, the Commercial Ambassador of the self-designated Government of Transkei, Ernest Blom, arrived in Santiago accompanied by a large retinue to meet fascists at the highest level and a group of Chileans who represent United States finance capital there.

This second public mission sent by the South Africans to Chile, in the name of the Transkei, had the aim of achieving recognition of the fact of the false independence of the bantustan. It was agreed that the Pinochet Fascist Junta would open a commercial office in Transkei, while South Africa would open a commercial office in Santiago in the name of the Transkei.

VORSTER IS ALSO RHODESIA'S REPRESENTATIVE TO PINOCHET

The racist regime of Vorster actually acts as an agent of Ian Smith towards Pinochet in order to forge links between the two regimes.

Through Vorster's efforts, Pinochet is trying to do business with Rhodesia.

J. Hunlerty, a Rhodesian businessman strongly linked to Ian Smith, arrived in Chile as an "official guest" of the highest personages in Pinochet's economic system, which is diligently sacking Chile. It was officially stated that the Rhodesian had come to Chile to study the conditions for various investments that Rhodesian businessmen were planning to make in Chile. Hunlerty announced that

an official trade mission from the government of Rhodesia would soon travel to Santiago, adding eulogistic comments on the "economic policy" of Pinochet's military Junta, as well as describing his contacts with the Pinochet hierarchs as "very auspicious".

"GOOD WILL" BETWEEN PINOCHET AND VORSTER

In October 1976, Vorster sent to Pinochet his Under Secretary of the Interior and Information, Luis La Grange, on what he called a "goodwill" visit.

While on Chilean soil, La Grange took the opportunity to talk with the Under-Secretaries of External Relations, Interior and Treasury: Colonel Enrique Valdes, Air commander Enrique Montero and Naval captain Pedro Larrondo respectively. At the same time, he met private magnates grouped in the Sociedad de Fomento Fabril and with Enrique Ortuzar who heads a group which Pinochet formed, pompously calling it "Constituent Commission of the New Constitution", through which he is trying to institutionalize fascism in Chile.

After this "goodwill" visit, Pinochet began to implicitly support South Africa in all international forums, including the United Nations. While the latter was recommending boycott of the apartheid regime, Pinochet was already increasing ties in precisely those areas where the international organization was calling for the immediate halt of all assistance, particularly military and economic.

In May 1977, the group of fascists who usurped the government in Chile refused to attend the International Conference of Support for the Peoples of Zimbabwe and Namibia, organized by the Decolonization Committee of the U.N.O. and held in Maputo, Mozambique, resorting to a very coarse lie. In a note addressed to the Secretary General of the U.N., Mr. Kurt Waldheim, the group of Chilean fascists made it known that they would not attend the Conference in Maputo, because the President of Mozambique, Samora Machel, had referred "in offensive terms" to Pinochet and his regime.

Mozambique, of course, was not even participating in the organization of the Conference, as this was the responsibility of the U.N.O. itself and it had only agreed to offer to be the venue for the same. Furthermore, the Mozambican leader had only expressed an opinion on Pinochet in the same way as the majority of the governors of the world.

The Pinochet regime had certainly crudely insulted all Africans in calling them "savages"... "who practice cannibalistic tribalism" and other remarks like that.

ECONOMIC TIES BETWEEN VORSTER AND PINOCHET IN THE OPEN

The Prensa Latina Agency correspondent at the United Nations issued on 9th November 1974 a report which reveals the use of the group of terrorists headed by Pinochet as the spearhead of the penetration of South African racism in Latin America.

The report says " South Africa offered important credits to Chile, as well as financial and technological aid to be applied in the field of mining, especially in the extraction and marketing of copper".

Robert A. du Plooy, one of Vorster's diplomats and head of the delegation which participated in the talks with Pinochet's emissaries, then showed keen interest in the broadening of relations with Chilean fascism. He asserted : "Chile offers attractive conditions for foreign investment and commercial exchanges".

Exactly 9 months later, 9th August 1975, the "Financial Mail" revealed that the relationship between the Pinochet and Vorster regimes was getting "warmer" and acknowledged that the total trade of South Africa with Pinochet, between 1973 and 1974 alone, had reached 15.2 million dollars.

The same newspaper revealed on that occasion that "Ovenstone Investment", a South African company nationalized by Chile during the legitime regime of President Dr. Salvador Allende, was to return to Chile to again exploit the country.

A manufacturer of mining equipment "Shaft Sinker", offered for its part to carry out studies on the existing possibilities in the field of gold mining in Chile.

Other interests were already preparing to exploit a fertilizer concern in Chile.

At the same time it was revealed that missions from the "South African Industrial Development Corporation" and "Credit Guarantee Insurance Corporation" had visited Chile under Pinochet to examine the possibilities of widening export credits there.

The Pretoria regime is getting ready to transfer to Chile the Mining Adviser based until then in Buenos Aires, the report added.

Almost at the end of October 1975, no less than the Bulletin of Pinochet's Chancery, which is distributed in all the foreign diplomatic missions and through various telegraphic agencies, acknowledged that talks had begun between the Junta's representatives and Vorster's ambassador to Pinochet in order to study possible South African investments in the extractive industry of Chilean copper and others of medium term in the manufacturing sector.

Between 2nd and 7th March 1976, the commercial representative of South Africa for the American Southern Cone, Len Kleinman, made an official visit to Pinochet. In Santiago, he also held talks with the representative of the Central Chamber of Commerce, analyzing projects to reinforce commercial exchanges between the two regimes.

In May of the same year, that is only two months later, businessman Richard Kerm Martin of the "South African Foreign Trade Organization" arrived in Chile to make contact with the organization created by Pinochet under the reverberating name of "Institute for the Promotion of Chilean Exports", with whom he studied the possibilities of purchasing specific products.

"El Mercurio", mouthpiece of Chilean fascism, reviewed on 27th October 1976 the activities developed by the "Institute for the Promotion of Chilean Exports" in its two years of existence, stressing its participation in the Pretoria Fair, S.A. Currently the Chilean fascists are importing mainly from South Africa the "briquettes" used in the smelting of copper. The country pays out a million dollars annually for the import of "briquettes".

The Bulletin of the Chancery of the fascist Pinochet military Junta acknowledged on 19th November 1976 that the "Sociedad Minera Pudahuel Ltda" had received credits, mainly from South African banks, for a total amount of 27,660,00 dollars, capital destined to finance a project to obtain electrolytic copper from the minerals of "Lo Aguirre".

The Vorster regime covets Chilean uranium. On 7th December 1976 the Chilean Commission for Nuclear Energy acknowledged that a score of foreign enterprises had tendered to exploit reactive minerals in the country. The case of two large South African concerns was stressed. The latest news shows that negotiations are being finalized.

POLITICO/SPORTING UNITY BETWEEN PINOCHET AND VORSTER

On 5th June 1975, the Chilean fascist magazine "Que Pasa" advised that Pinochet's Junta had arranged for the tennis players of that country to face the South Africans in the final match for the American zone of the Davis Cup, between 19th and 20th of the following July. South Africa has to participate in the American zone as she is forbidden to do so on her own continent.

The requisite match in Santiago took place because Colombia and Mexico preferred to lose their opportunity of qualifying for the finals of the Davis Cup rather than have to meet the South African racists.

The match between Pinochet's Chile and Vorster's South Africa took place on the mentioned dates, in none other than the National Stadium of Santiago; the same one that served as a Concentration Camp and centre of tortures and innumerable killings for thousands of Chilean men and women immediately after the fascist military coup.

In 1976, this attitude was maintained by Pinochet, which allowed the racist sportsmen to again appear in the Stadiums of the Chilean capital. The adoption of this decision by the Pinochet Junta - which also siezed control of all sport in Chile - has demonstrated that the fascists are prepared to go to the bitter end in their relations with the racist Vorster regime, ignoring all the recommendations of the United Nations not to establish any kind of links with the macabre apartheid regime.

PUBLICITY FOR VORSTER'S RACISM IN PINOCHET'S CHILE

One of the dearest traditions of the Chilean people is that of having always struggled against all forms of oppression. Its national anthem intones : "either the tomb will be for the free, or an asylum against oppression".

Therefore, Chile has always been a people which struggles for the independence of all peoples and - naturally - against racism.

In view of this, the Vorster regime was obliged to engage the services of the multi-million dollar propaganda machine of the most reactionary circles of North American capitalism, McCann Erikson, to publicize and distribute through the newspapers, magazines, radios and television channels a series of advertisements,

jingles and spots intended to spread in Chile the "bounties" of South African racism.

The publicity for racism in Chile, among other things, invites Chileans to visit South Africa, where according to their plea "no-one feels a stranger". The South African Airways, SAA, are represented in Santiago by LAN Chile, a state concern siezed by the fascists with which the South African government signed a commercial/tourist agreement. This concern serving the South African racists operates from its offices situated at Agustinas 1191, Santiago, telephone: 84285-61307 - 65201.

The advertisements which speak of " a unique country - that is South Africa " contain slogans such as "Johannesburg: modern commercial city with monumental building and sophisticated entertainment centres"; "Zululand : primitive civilizations whose traditions are maintained intact", etc. Vorster's regime repeats "South Africa: where no-one feels a stranger" to Chileans who live under the Pinochet regime. " A unique country - that is South Africa ".

This ideological offensive of the Vorster regime in Chile has the support of all the mass communications media which have fallen into the clutches of Pinochet's fascism, and takes in an infinity variety of aspects. Thus, to give just one more example, in its edition of 14th September 1975, "El Mercurio" was already promoting the purchase of racist books in the following terms : "... this collection of refined publications includes a report on national reality during 1974 which, like the previous titles, is destined to defend the external image in the face of the obstacles it encounters in the circles of the international community".

"Prelude to Detente" and "South African Tradition" are some of the books most promoted by the Vorster regime in Pinochet's fascist Chile.

Furthermore, "broad official exhibitions of South Africa" of a political and propagandistic nature take place in Santiago and other Chilean cities.

UNITY OF THE "JUSTICES" OF PINOCHET AND VORSTER

The major concealer of all the crimes of Pinochet, the President of the so-called "Supreme Court" of Chile, Jose Maria Eyzaguirre, has not hesitated to show himself openly as a fervent supporter of the racist Vorster regime.

Eyzaguirre, who even conceals the aberrant case of the 2500 "disappeared" in Chile, tightly tied the existing links between the so-called "justices" of the fascist Chilean and racist South African regimes with his latest visit, of an "official" nature, to the apartheid kingdom.

The Vorster regime specially invited the President of the so-called "Supreme Court" in the service of Pinochet, Jose Maria Eyzaguirre, for the commemoration of the new anniversary of the so-called South African "Supreme Court", sitting in Transvaal. This scandal took place between 17th and 27th May 1977.

On his return, Eyzaguirre yielded wide information about his visit to Pinochet himself, relating in detail not only his public contacts but also, above all, giving account of the private tasks that the fascist dictator himself had recommended that he perform "in secret".

The following 6th June, the Western agency Inter Press Service distributed some of the words of the President of Pinochet's "Supreme Court" after his visit to South Africa : " It is a country of extraordinary development", he said " with a very high standard of living, great riches and very accentuated industrialization. Of course, it has quite a keen racial problem, but the authorities of the South African government are trying to gradually produce integration between the black and white communities. "

Eyzaguirre also said **that** the leaders of the South African government have " a very wide knowledge of Chile ", as their nation " is presently being attacked by the United Nations and is experiencing a similar situation to that of Chile in the international field".

TRANSPLANT OF APARTHEID TO CHILE

Through the Vorster regime, Pinochet has also become connected with the regime of Ian Smith in Rhodesia.

It has been reported recently that the fascist Junta of Chile is interested in receiving Rhodesian colonists emigrating from Africa to their territory, thus effecting a de facto transplant of apartheid to Chile.

Of course, some sectors of Chilean fascism are interested that this should occur at the earliest possible moment, On 24th April 1977, "El Mercurio" the leading

mouthpiece of the Pinochet military Junta, publicized a letter signed by Frank Herbert Engel, identity cell no. 1628611 of Santiago, which states : " I am of the opinion that the corresponding authorities of our country also should look into the ways of attracting these emigrants. For this, it would be profitable to carry out adequate planning. Our history shows the positive advantage of this type of emigration, it being sufficient to recall the German emigration of 1948".

It should be remembered that in the period subsequent to the Second World War, notorious Nazi war criminals arrived in Chile. To quote only one case, living in Chile are persons such as Walter Rauff, confessed assassin of more than 100,000 people in gas chambers manufactured by himself on lorries.

The fanatical Hitlerian, Walter Rauff, has just declared in Punta Arenas, the extreme South of Chile, that " in war everything is permitted and therefore my conscience is extremely clear"

These are some of the innumerable irrefutable facts which demonstrate the political, military and economic conspiracy between the fascist regime of Chile headed by Pinochet and South African racism and its lackeys ruled by Vorster.

A conspiracy which threatens not only the South African and Chilean peoples, but by its very nature, the whole human race.
